Pamflete House and the Bosun's Cottage are situated on the 5,000-acre Flete Estate, located in Devon between Dartmoor and the sea, along the beautiful Erme estuary. The estate has been in the Mildmay-White family since the 1870s when Henry Mildmay bought Mothecombe House, Flete House, and the estate. Mothecombe House is a Queen Anne home built in 1710, with a dining room, garden passage, and terraces by Sir Edwin Lutyens.

Both the Grade II listed Pamflete House and the nearby Bosun's Cottage offer beautiful views across the Pamflete valley and are only a short walk from the beach. Amenities include: Two acres of garden, club-sized tennis court, croquet lawn, pool table, table tennis, WiFi, and log fires. Please note that not all rooms are en suite.
